Tenaska generation manages, owns and/or operates one of the safest and most reliable power generating portfolios in the United States. Its natural gas, wind and solar facilities total more than 6,622 megawatts (MW) across 16 plants in eight states, with average emissions rates among the lowest for U.S. fossil-fueled plants.

Tenaska-operated facilities maintain strong safety programs and are consistently recognized by the National Safety Council, receiving some of the industry's most prestigious safety awards. Five facilities have earned Voluntary Protection Program (VPP) Star designation, the nation's highest safety distinction.

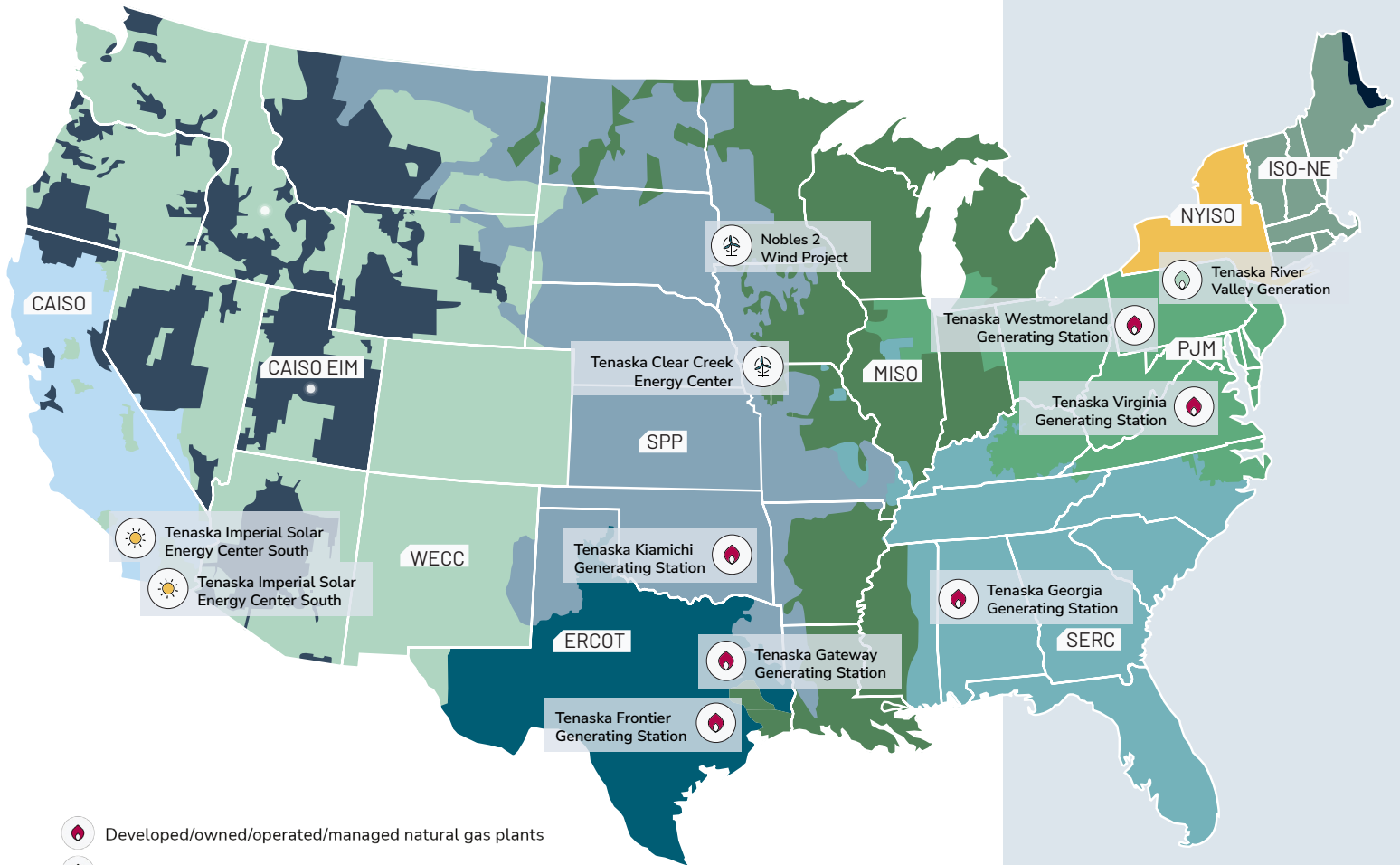


