Capacity

885 megawatts to meet the electric energy needs of up to 885,000 homes.

Reliable Generation

Forced outage factor of 1.3% over the past five contract years.

Meets all applicable environmental permits and standards. Uses clean-burning natural gas, along with effective control technology, to ensure low emissions and environmentally responsible operation.

Employment

23 well-paying, full-time positions to operate the facility. These employees and their families live, pay taxes and purchase goods and services in Alabama.

Economic Impact

Approximately \$7.2 million in salaries and payments to local contractors and vendors in 2019.

Local and State Tax Revenue

Tenaska Central Alabama's owner is a top taxpayer in Autauga County. At the same time, the plant places no significant demand on local services, such as police, fire or roads.

- Through 2019, the Tenaska Central Alabama Generating Station has paid more than \$15.4 million in property taxes.
- The facility provided approximately \$1.33 million in mortgage recording taxes to Autauga County and the state of Alabama.

Safety

- Recipient of four National Safety Council awards in 2018 for safety achievements.
- Tenaska Central Alabama employees have worked more than 10 years without an occupational injury or illnesses involving days away from work.
- Awarded status as Voluntary Protection Program Star Worksite by the U.S. Occupational Safety and Health Administration (OSHA).

Citizenship

Involvement occurs both at the corporate and individual levels. Examples:

- Tenaska Central Alabama donated use of a home and property to the local Boy and Cub Scout troops and other community groups.
- Tenaska Central Alabama, its power customer, Shell Energy, and its contractors donated and installed new playground equipment at the Billingsley School.
- Tenaska Central Alabama and the nearby Tenaska Lindsay Hill Generating Station sponsor a college scholarship program to benefit Autauga County high school students. To date, 186 graduates have received \$159,000 in scholarships.
- Tenaska Central Alabama makes annual contributions to three local fire departments and the City of Billingsley for community enhancement.
- Tenaska Central Alabama and its employees volunteer their time and have helped fund the local United Way campaign, American Red Cross, USO, Cystic Fibrosis Foundation, Oak Mountain Park Trail Committee, county holiday programs and community improvement projects.
